Activities Agreement

To ensure the proper atmosphere for interscholastic competition, the participant and his/her parents or guardians must understand and cooperate in helping establish that atmosphere by adhering to all school rules and regulations. When a violation of school rules occurs, proper steps will be taken. In addition to Bremen City School Board Policy and the respective school's student handbook, the following offenses will result in immediate dismissal from participation with a team/group for a minimum of 20 school days. This applies to the extracurricular activity only and not to a scheduled class that may be associated with an activity. The dismissal may be carried into an upcoming season/semester/next school year.

1. Weapons-use or possession
2. Alcohol or other drug violation-use or possession
3. Tobacco-2nd offense-use or possession

A student must have his/her parent's or guardian's signed permission to participate. All athletic participation requires a physical examination with the doctor's permission to participate. The participant is required to abide by the rules and regulations of the State Board of Education, the Georgia High School Association.

Informed Consent

We realize that such activities involve the potential for injury to our child which is inherent in all activities. We acknowledge that even with the best coaching, use of the most advanced protective equipment, strict observance of the rules, injuries to our child are still possible. We recognize that on rare occasions these injuries can be so severe as to result in total disability, paralysis, or even death.

General Release

It is anticipated that my child, while a participant in interscholastic activities in the Bremen System, will travel to many activities off campus. Transportation for my child to these off campus activities will be by bus or private vehicle with consents. In consideration of their performing this valuable service for me and my child, I hereby release and discharge any and all claims and causes of action of any kind or nature which may arise out of my child's travel while at school both for myself and my minor child. It is the express intent of this release to forever hold the Bremen System, its agents and employees, harmless from any injuries which may occur to my child as a result of travel while he or she is in the custody of the School System.

Insurance Waiver

I fully understand that the Bremen School System does not provide any insurance coverage for my child. The Bremen School System will not assume liability for injuries incurred by my child during participation in or practice of any interscholastic activity. A parent/guardian may elect to enroll the participant in a supplement school insurance program which is authorized by the Bremen School System. If you choose to purchase coverage through this plan, contact the school principal or head coach for additional information.

Student/Parent Concussion Awareness Form

DANGERS OF CONCUSSION

Concussions at all levels of sports have received a great deal of attention and a state law has been passed to address this issue. Adolescent athletes are particularly vulnerable to the effects of concussion. Once considered little more than a minor “ding” to the head, it is now understood that a concussion has the potential to result in death, or changes in brain function (either short-term or long-term). A concussion is a brain injury that results in a temporary disruption of normal brain function. A concussion occurs when the brain is violently rocked back and forth or twisted inside the skull as a result of a blow to the head or body. Continued participation in any sport following a concussion can lead to worsening concussion symptoms, as well as increased risk for further injury to the brain, and even death.

Player and parental education in this area is crucial – that is the reason for this document. Refer to it regularly. This form must be signed by a parent or guardian of each student who wishes to participate in GHSA athletics. One copy needs to be returned to the school, and one retained at home.

COMMON SIGNS AND SYMPTOMS OF CONCUSSION

- Headache, dizziness, poor balance, moves clumsily, reduced energy level/tiredness
- Nausea or vomiting
- Blurred vision, sensitivity to light and sounds
- Fogginess of memory, difficulty concentrating, slowed thought processes, confused about surroundings or game assignments
- Unexplained changes in behavior and personality
- Loss of consciousness (NOTE: This does not occur in all concussion episodes.)

BY-LAW 2.68: GHSA CONCUSSION POLICY: In accordance with Georgia law and national playing rules published by the National Federation of State High School Associations, any athlete who exhibits signs, symptoms, or behaviors consistent with a concussion shall be immediately removed from the practice or contest and shall not return to play until an appropriate health care professional has determined that no concussion has occurred. (NOTE: An appropriate health care professional may include licensed physician (MD/DO) or another licensed individual under the supervision of a licensed physician, such as a nurse practitioner, physician assistant, or certified athletic trainer who has received training in concussion evaluation and management.

a) No athlete is allowed to return to a game or a practice on the same day that a concussion (a) has been diagnosed, OR (b) cannot be ruled out.

b) Any athlete diagnosed with a concussion shall be cleared medically by an appropriate health care professional prior to resuming participation in any future practice or contest. The formulation of a gradual return to play protocol shall be a part of the medical clearance.

By signing this concussion form, I give Bremen Middle School permission to transfer this concussion form to the other sports that my child may play. I am aware of the dangers of concussions and this signed concussion form will represent myself and my child during the 2017-2018 school year. This form will be stored with the athletic physical form and other accompanying forms required by the Bremen City School System.
